Dear Induprakash Mishra and Somya Mishra,
We sent you our first legal notice on 24-7-2011 that you are using deliberately the service keyword – **Bhavishyavani** – of our client **Ved Bhawan International**. However you have no such relevance of this name on your website and your domain. You are using this name to mislead our potential clients. You are using this word in bad faith and causing infringement of intellectual property and brand names.

You also didn't respond on our request to withdraw this offence.

Seeing no such result we are now compelled to move forward to take action against you. We wish to notify you that –

1. We have put a penalty of US \$3000 on you for this offence and a damage claim of US \$1000 per day so long you use our name and service brand. This amount you need to pay to our India Office on their bank account. Please contact them on this email – info@vedbhawan.in to get the bank details and/or any alternative method of payment. This penalty must be paid before August 2, 2011.
2. We have also blacklisted you in more than 10 Indian and international database and your details will be publically blacklisted through whole internet. We will also alert our clients on our website that you are misleading them using our brand name – Bhavishyavani.
3. We have already informed your domain registrar and hosting provider company for this infringement and they have suggested us to go ahead with legal proceeding for a remedy. So at the same time we now also move forward for this and you will be summoned in the court of Faridabad. At the same time we also launch a case by the international court that will block you visiting any country out of India or doing business with them as threat of cyber crime activities.
4. We will also register a FIR at your local Police Commissioner under Indian Cyber Crime Cell.

5. At the same time we also have written to the Income Tax Department of India to investigate your financial activities and legal grounds in case we may need to recover all our losses that happened due to your misleading use of our brand name by which you earned from our (to be) clients.

In a regular check by our internet monitoring team we have discovered that you are using word “Bhavishyavani” in your website header on your website – www.acharyainduprakash.com - without having such right or permission. See below -

Bhavishyavani Services (www.bhavishyavani.com) is an undertaking of **Ved Bhawan India** and is the property of us. Ved Bhawan is a registered society in India under society registration Act 1860. You haven't attained any permission from us to use this world in any means and you are using it to mislead our clients in bad faith.

However we normally proceed with a criminal proceedings under cybercrime act and also a civil proceeding for a penalty and damage claim starting \$55,000, we hereby provide you the opportunity to withdraw your offence and prevent such legal troubles. We give you 48 hours time to remove this word – Bhavishyavani – or any resembling word or tricks from all your websites and keep it removed.

We will check once more on Tuesday July 26,2011 and if we found our keywords still on your website then we will –

1. Proceed with the criminal and civil proceedings

2. We will blacklist you and your website on internet
3. We will notify Google and other search engines to remove your website from searches under violation of intellectual property rights and for using misleading key words/titles/tags
4. We will also notify Go Daddy Inc. to abandon your domain.

Hope to have served you this notice in advance and accordingly.
